Greg, thanks for sending the memo to me. I am working on a story about your role in the Pellerin property purchase and would like to speak with you.

Among the questions I have is whether you took any additional steps outside of this memo. As you probably know, a potential ethics violation cannot be cured with this type of waiver.

Ethics Administration tells me you did not seek an advisory opinion about your conflict of interest in this matter.

You appear to acknowledge in the memo that you took LCG officials on a tour of the property in 2020 when Andrus was still alive and that you later shared the family's appraisals with LCG. Can you tell me why you did not seek an advisory opinion from Ethics before any of this took place?

Were you being paid by the Pellerin family or the succession at the same time you were being paid by LCG? Did you benefit financially from the Pellerin family as a result of this property transaction?

You asked Josh to sign off on this as a matter and led him to believe the waiver would also apply to the Board of Ethics. So it appears as though you misled him. Do you care to address this?

In the memo you suggest that the matter be assigned to Becker and Hebert, yet they work for you. So how does this cure your conflict in any way? And you even acknowledge a desire to stay on and work through Mike Hebert, so you did not actually step away from the conflict at all.

Has the Board of Ethics notified you that it has launched an investigation into this issue of the property acquisition or any matter for which a complaint against you has been lodged?
